- 1. ALL APPLICANTS MUST SUPPLY ONE (1) ORIGINAL PERMIT APPLICATION (see above to download appropriate permit application form).
- 2. CONTRACTORS MUST ALSO SUPPLY:
 - COPY OF DRIVERS LICENSE
 - COPY OF CONTRACTORS LICENSE
- 3. ALL APPLICATIONS MUST HAVE A <u>"VERIFICATION OF TAXES</u> <u>CERTIFICATE"</u> APPROVED BY THE TAX COLLECTOR PRIOR TO ISSUANCE OF ALL PERMITS (SEE INSTRUCTIONS BELOW)
- 4. PERMIT APPLICATIONS CAN BE SUBMITTED VIA:
 - PRESENTED IN PERSON TO INSPECTORS WEDNESDAY EVENINGS 7-9 PM.

5. <u>REQUIRED DOCUMENTATION FOR BUILDING PERMITS</u>:

- IF YOU ARE APPLYING FOR ANY "OUTWARD" EXPANSION OF A BUILDING YOU MUST HAVE PLANS AND AN APPROVED ZONING CERTIFICATE.
- IF YOU ARE APPLYING FOR "INTERIOR" RENOVATIONS, WINDOWS, SIDING, OR ROOFING-PLANS ARE NEEDED (NO ZONING CERTIFICATE REQUIRED).

ALL INSPECTIONS ARE SCHEDULED BY THE INSPECTORS

APPROVED PERMITS ARE AVAILABLE FOR PICKUP THURSDAYS <u>AFTER 10A.M.</u> AT THE TOWN HALL- 2ND FLOOR

PERMIT FEES ARE PAYABLE BY CASH OR CHECKS (MADE PAYABLE TO "TOWN OF EXETER")

All permits must have a <u>Verification of Taxes Certificate</u> approved by the Tax Collector <u>PRIOR</u> to applying for permit.
